We have reviewed your transmittal letter dated February 10, 2011, requesting a boundary interpretation for the subject parcel. A number of other individuals have expressed an interest in this interpretation. Based on our analysis of the Commission's official maps and records currently on file at our office and the materials that were provided to us by the Kaua`i County Planning Department, we have determined an approximate location of the State Land Use (SLU) Agricultural/Conservation District boundaries on the survey map entitled, "Map Showing Lot 1, Being a Portion of Lot D-1 of Land Court Application 1161 (Map 4)".

For your information the Agricultural / Conservation District boundary follows an average setback of 300 feet from the high water mark and also as depicted on SLU District Boundaries Map K-9, Anahola Quadrangle, dated December 20, 1974.

Please be advised that our determination is subject to revision based upon the provision of a valid certified shoreline survey prepared in accordance with §13-222-11, Hawai`i Administrative Rules. In the event such a valid certified shoreline survey becomes available, we reserve the right to re-examine our determination and make any changes that we deem are necessary.
